# Shake off negative thinking and get into 'navigator' mode

In my previous column on Aug. 19, I promised to offer some guidance as to how to go from "victim" mode to "navigator" mode at work. Let me explain by recalling a bumper sticker I saw two years ago while writing a book about how to cope with the stress of organizational change.

"On my way to work," it said. "Please kill me."

The outlook behind that sticker was that of what I called the victim mentality. American workers seem to know all about this way of being: The American Psychological Association reported earlier this year that 49 percent (up from 44 percent last year) of Americans say their main sour ce of stress is profound fear about losing their jobs. No wonder that in another study 49 percent of workers said they would not recommend their company as a place to work.

During workplace upheaval, most people actually choose the "sur vivor" approach over that of the victim. In sur vivor mode we go through our days planning for the worst while hoping for the best. Over the long run, this can work out better than

'None of us are in complete control of how things turn out.' victim mode, but wins no awards for peace of mind, and we spend our days in a state of perpetual tension often leading to physical and mental distress.

Alternatively, we can respond to a challenging work-place by functioning as what I call a navigator, keeping our wits and optimism

about us while stressful events take place.

If you find yourself behaving like a victim or survivor at work but want to be more like the navigator, you need to examine — and adjust, if necessar y — your mental viewpoint about change. Here's what I mean: Choose which of the following statements best characterizes your outlook these days:

- 1. Change at work brings good for tune about as often as it creates bad outcomes.
- 2. Change at work usually provides people with an opportunity for growth.
- 3. Change at work usually tur ns out poorly for people like me.

The person in victim mode expects the worst (No. 3) and the person in sur vivor mode is more hopeful (No. 1). Still, both bet on the present. Navigator mode (No. 2) calls on us to see the possibilities in change for opening doors that other wise would be closed. Of course, navigators know that the kind of change that matters most — and is hardest to effect — comes from within. Even then, there are no guarantees. Somehow, some way, you must learn to catch yourself if in victim or survivor mode and shake yourself out of it.

Here is another set of options regarding one's feelings about the unknown. Which is the stance of the navigator?

- 1. Life is one problem after another.
- 2. Life is a series of good days and bad days in about equal measure.
- 3. Life is a thrilling adventure.



This has to do with your attitude about control: No one has it all the time. T ug McGraw, the relief pitcher who famously

threw the winning strike in the 1980 World Series for the Philadelphia Phillies, knew — based on his team's loss of the Series in 1973 — that "some days you tame the tiger. Some days the tiger has you for lunch."

None of us are in complete control of how things turn out. But if we fully use the greatest asset we have — our cer ebral cortex — we can remind ourselves that we can be much more influential than we think at affecting the outcome of things

even when we're hidden deep in the corporate hierarchy. Doing what comes most naturally, i.e., staying in victim and sur vivor modes, can make things far worse.

Shake yourself out of victim mode! Reject the survivor mentality! Set a destination and chart a course! Get into navigator mode!



form is largely based west of the Mississippi River. Since merging into Nationwide in 1998, Browne and Nationwide CEO Steve Rasmussen said Allied has seen its premiums grow from \$800 million to \$3.5 billion and its employees jumped from 1,200 to 4,000 while maintaining its original brand name.

With Harleysville Group, Nationwide gains an independent agency platfor m in 32 states, with the bulk of the pr emiums east of the Mississippi. Browne said of Harleysville's 1,300 independent agencies, only about 100 also sell Allied products.

Based on 2010 data provided by the company, Harleysville Group's \$1.14 billion in premiums have the largest concentration in New York (\$267 million), Pennsylvania (\$221 million), New Jersey (\$146 million), Massachusetts (\$67 million) and Virginia (\$54 million).

Browne said the chance to duplicate that growth formula, combined with a sale price roughly double Harleysville Group's book value, made the deal enticing.

"This was too good of an oppor tunity to pass up," Browne said. "Over the past eight years, we have improved the company. But there wasn't any growth. We've been in a soft market. Nationwide gives us more products and a deeper financial platform. And I also like that we will no longer be a public company and will r eturn to being a mutual [insurance company]. Mutuals have the ability to look at the long term and make investments in people and products without worrying as much about [quarterly] financials."

Browne said the name will change slightly to Harleysville Insurance Co.

Browne will remain president and CEO at Harleysville Group, which will be a wholly owned Nationwide subsidiary. The deal is expected to close early next year.

Rasmussen said Harleysville Group will be selling a broader product suite — adding life insurance, benefits, annuities in addition to financial services business lines from Nationwide.

"There might be some overlap," Ras-

mussen said, "but we are going to add more people. We appreciate small towns and long-term employees. They are a tremendous asset."

This will be music to the ears of the roughly 900 Harleysville Group employees in the company's Harleysville head-quarters and the 170 in Mount Laur el, N.J., which combined equal the bulk of the company's 1,700 employees. This is especially good news for the town of Harleysville, which saw First Niagara Financial Group relocate its regional head-quarters to Plymouth Meeting after buying Harleysville National Group last year.

Browne said the company's community involvement will also continue.

Nationwide already has about 1,300 employees in the state, with close to 800 in Harrisburg, 140 in a claims of fice in Conshohocken and 80 in the King of Prussia headquarters for Nationwide Investment Management Group, its invest-

ment arm.

Nationwide also has about 500 exclusive agents in Pennsylvania and 140 contracted independent agents.

A spokesman said Nationwide generates a third each of its revenue from captive agents, independent agents and its financial ser vices

channel. Rasmussen said the captive and independent businesses have operated as separate business lines ever since Nationwide acquired Allied.

He said independent agency business tends to be more commercial while captive agencies focus more on personal lines. Rasmussen hopes Nationwide will be able to better compete with rivals like Travelers Insurance Co. and Har tford Insurance Co.

Alvin C. Alderfer started Harleysville Group in 1915 because he and car owners had no way of insuring against theft. Alderfer also founded Harleysville National and Harleysville Savings Bank. Harleysville Group went public in 1986 but a similarly named mutual insurance company owns 54 percent of it.

# **APARTMENTS:** As demand grows, developers are constructing more rental units

Conshohocken where it intends to build 300 units, purchased another 20 acres in the heart of Phoenixville for 400 apar tments and rezoned 15 acres at its New Britain Corporate Center in Bucks Country to multifamily for the construction of a 230-unit apartment community.

The company intends to look for mor e opportunities throughout the region.

"There's a compelling story based on demographics and demand," said Steve Spaeder, president of BPG Development Co., a BPG Properties affiliate. "This type of housing has been under developed for a long time because of high barriers of entry. Now there's a real and growing demand. It represents an opportunity to maximize some existing land assets and pursue opportunities where land can be acquired for apartments. Communities are also recognizing the need and are willing to zone for apartments where in times past they weren't necessarily willing to do it."

Other suburban projects:

E. Kahn Development Corp. of W est Chester expects to break ground soon with Cornerstone Properties of Villanova on a mixed-use project on East King Street in the heart of Malvern. The \$35 million project will consist of 190 apar tments, 25,000 square feet of retail and parking. The partnership is also planning to br eak

ground on 180 apartments at a site at Gay and Matlack streets in West Chester.

Cornerstone Properties is forming a partnership with Bozutto Group of Greenbelt, Md., to construct 250 apartments at its Terrazza project off Route 252 in Newtown Square. This is the second phase of the residential development and had originally been designated as condominiums:

Bolis Properties of King of Prussia bought the development rights to Appleview Apartments, a 200-unit, nine-building complex on 41 acres at Horseshoe Pike and Bollinger Road in East Brandywine. Construction is expected to start 2013;

O'Neill Properties Group is planning a 753-unit apartment complex at Uptown Worthington at Routes 202 and 29 in Malvern. Ground could be broken next year, according to the township;

BET Investments is completing a 192unit age-restricted rental community called Dublin Terrace;

Jefferson Apartment Group is constructing a 230-unit development at Route 202 and South Matlack Street in West Chester; and

Home Properties of New York wants to construct a new apartment complex at 1101 E. Hector St. in Conshohocken and is going through the approval process.

A combination of factors is driving the rise in apartment construction. Demo-

graphics, a difficult housing market and tough mortgage lending environment have culminated to create a strong climate for those who own apar tments and developers seeking to construct them.

"Rental versus ownership is shifting and has been and will continue," said Steve Mullin, senior vice president at Econsult Corp.

Echo boomers, the 80 million people born between 1980 and 1995, ar e greatly influencing the trend, Mullin said. The first wave of them is starting to enter the work force. They are of prime renting age. Saddled by student loans and other debt, many of them can't save enough money for a downpayment on a house or they don't qualify for a mor tgage, which aside from living at home with their par ents, makes apartment living their only choice.

Communities have also begun to embrace multifamily whereas they didn't before, Mullin said. Years ago, towns were adverse to such dense development; school districts didn't want them because renters don't pay property taxes, but their children use the local schools and other community services.

"Today, they have decided they can accept more density," he said. "This is also a case of stagnating property taxes and growing the tax base."

While the echo boom is a major par t of this, baby boomers, who helped fuel the

single-family housing market for the last two decades, are now starting to retire and looking to scale down. Some ar e selling their big houses and maintaining multiple smaller ones instead, said David Della Porta of Cornerstone Properties.

"They don't want to be tied down to the big house," Della Por ta said. "They are buying and renting."

Other factors at work is the market. Multifamily is one of the hottest property types in real estate and investors have been buying up existing properties because of demand. As values have gone up, it has justified the construction costs of new apartments, said Michael P. Markman, president at BET Investments in Horsham.

Where they build is also important. Apartment developers are seeking out sites that have existing infrastructure, close to public transit and near other amenities such as restaurants and outdoor recreation.

"It's smart growth and that's where multifamily is coming from. It's infill development as opposed to green space," said Jeff Mack of Newmark Knight Frank Smith Mack, who helped arranged the sale of the 20 acres in Conshohocken to BPG Properties.

Land in the area is also a bargain compared with other regions by a "significant factor," Mack said. "That makes it ver y economical.

# WATERFRONT: Fortunes of Seaport Museum integral to sustaining Penn's Landing

last leader in May.

The fortunes of the Seaport Museum — and those of Brady — are integral to those of Penn's Landing and the waterfront, contributing to its appeal as a "destination."

Indeed, a decade after Simon Pr operty Group's proposed retail-and-entertainment complex fell through, the attractions on Penn's Landing and the water front remain a work in progress. The Philadelphia Belle paddlewheel party boat, overhauled at a cost of millions of dollars, folded after less than a season on the river, and other ideas for the water front have come and gone.

"There's no way around it. We're very much tied together. It's a tremendous help to us if people are visiting Penn's Landing. There's no question having mor e would help us tremendously," said Brady. After the failure of the retail-and-entertainment complex, the strategy of the city and Delaware River Waterfront Corp. now calls for a more user-friendly space, with grassy stretches replacing concrete and a redoing of the central plaza. It would also include better service from mass transit.

"My answer is different than it might have been a year ago. The city's waterfront plan has a goal of r econnecting the city to the waterfront," said Bill McLaughlin, the museum's board chair. "We are all in it together."

Yet Brady will also face the challenge of bringing stability to a museum beset by high expenses and recent turnover in leadership.

Brady served as interim CEO since May before the museum's board removed the interim tag last month.

His immediate predecessor, Capt. John Gazzola, lasted eight months on the job. Gazzola, in turn, had replaced Lori Dillard Rech, who was there less than three years. Rech had replaced John S. Carter, who is in prison after admitting to embezzling from the museum. During each transition, there were months of interim leadership.

"John Gazzola is a wonder ful guy who had great connections in the city and added a lot," McLaughlin said. "John Brady represents the core of the museum and what it will be going forward."

Matt Murphy, who edits WoodenBoat Magazine in Brooklin, Maine, has known Brady for more than a decade. He called the Penn's Landing institution a "world-class museum," based on its nautical exhibits and Brady's work to r estore and build historically accurate boats.

"He's an incredible leader, a natural leader," said Murphy. "Part of John's job will be attracting wealthy benefactors, and I think he's demonstrated he could do that in the boat shop," where yacht commissions are part of the business.

Brady will run the museum along with Chief Operating Officer John Hunter. Basically, Hunter oversees finances and the physical operations, while Brady oversees the creative side of the museum.

Together, they'll face the challenge of stretching the museum's thin resources, a staff of 30 and an operating budget of \$4 million.

"We definitely to to work on building it

up," Brady said of the operating budget. "We need to see increases in visitation, increases in fundraising and increases in earned income."

The museum hopes to boost the museum's annual attendance from 60,000 to over 100,000, which would provide more operating income and make operations more sustainable.

Increasing attendance will require a great deal of cooperation, Brady said. The museum will work with other or ganizations, like Greater Philadelphia Tourism Marketing Corp., which markets the city to tourists, but also improving the relationship with the Hyatt at Penn's Landing, an adjacent hotel that sees a constant stream of visitors.

"All the chaos at Penn's Landing over 10 years has certainly not helped it. It's difficult to find — and I know where it is," said Nancy Kolb, former director of the Please Touch Museum and person behind its move to Memorial Hall. "I think what they

need is an endless str eam of special events to increase awareness ... The exhibits need updating. Rather than aiming at specialty nautical collectors, they need a family audience."

In the next year, the museum will launch two major exhibitions.

"Disasters on the Delaware," which will deal with how first-responders react to boiler explosions, oil spills and other calamities. The July 2010 Ride the Ducks accident that killed two tourists may be mentioned, Brady said, but only in the context of how first responders reacted. "It's too soon" to do anything mor e, he said

Another exhibition, organized with the Philadelphia Museum of Art, will commemorate the bicentennial of the War of 1812. Brady also hopes to bring in a ship like the Pride of Baltimore to attract additional attention.

Brady hopes having more rotation in exhibitions will generate more interest from visitors.

To cut expenses, the museum hopes to find another home for the Spanish American War cruiser Olympia, which is docked outside the museum. To refurbish the craft — the oldest and lar gest of its era still in existence — would cost an estimated \$20 million. The museum has received bids from six organizations to take control of the ship, but the process could take two years.

"I can't emphasize how important the ship is [to American naval histor y]," Brady said. "It should be preserved, but not by us." PHILADELPHIA BUSINESS JOURNAL



# Immigration and fear

hortly after I arrived in Birmingham, Ala., almost six years ago, I heard about Lorna Road.
As a matter of fact, if you followed the comments

As a matter of fact, if you followed the comments on the daily newspaper's website, you realized that this unassuming stretch of blacktop that cut through an older, inner-ring suburb was almost a local obsession.

Every day, Latino laborers would congregate on the sidewalks waiting for a chance to work, usually in construction in the new residential developments that were multiplying on the edge of town or on the vegetable farms a little further away from Birmingham.

Lorna Road made people angry — an emotion that I honestly never understood. It was early 2006 when I came to Alabama to become the editor of the Birmingham Business Journal. The economy was still humming, with employment about as high as it could realistically get. There weren't enough people to fill the jobs available, a situation that would change drastically within a couple years. Back in 2006, the anger wasn't about jobs.

I don't recall any truly serious crimes happening in that neighborhood. Most of the serious offenses in Birmingham are committed in the older, drug-infested areas of the city. The anger over suburban Loma Road wasn't about crime.

Was it neighborhood blight that made people mad? Lorna is lined by restaurants and retail establishments. Behind the stores are modest, mostly well-kept homes and apartment buildings. Blight wasn't a major issue, and it certainly wasn't the reason for all the vitriol.

What was the reason for the anger? Fear, pure and simple — the fear of someone coming into your community and taking something, whatever that something is, away from you. That's not unique to Alabama. Those fears are an American tradition. Philadelphia, for example, was once a flash-point for the "Know Nothings," who violently opposed the growth of Catholicism in America.

For the Alabamians obsessed with Lorna Road, the mantra was: "Something must be done!" And they were



right — something needs to be done about immigration. On the federal level, we need serious reform that includes enhanced border security and an expanded guest worker program with paths to citizenship.

With the absence of federal action, fear-fueled xenophobia becomes stronger and results in draconian legislation like the infamous Alabama law that passed the state legislature this year despite the objections of business groups, religious leaders and sheriffs. It passed, despite the fact that immigration, legal or otherwise, had little impact on the daily lives of the majority of Alabamians.

State politicians claim they are sticking to principle. The reality is, as the Birmingham News reported Oct. 2, "crops are rotting in the fields because farmers can't find enough workers to harvest them." Immigrant labor, legal and undocumented, is fleeing the state.

Like it or not, the law feeds into the stereotype of Alabama as an intolerant, hostile place.

Keith Smith, a sweet potato farmer and outspoken opponent of the law, told the News this: "If you want to solve the immigration problem, quit eating."

I love Alabama, one of the most beautiful states in the country. My daughter was born there and still has a little bit of a southern drawl to prove it. I feel a strong emotional attachment to the place.

But I'll never understand it.

To quote W.C. Fields, "I'd rather be in Philadelphia."

# **Homes not selling**

But houses still weren't being gobbled up.
